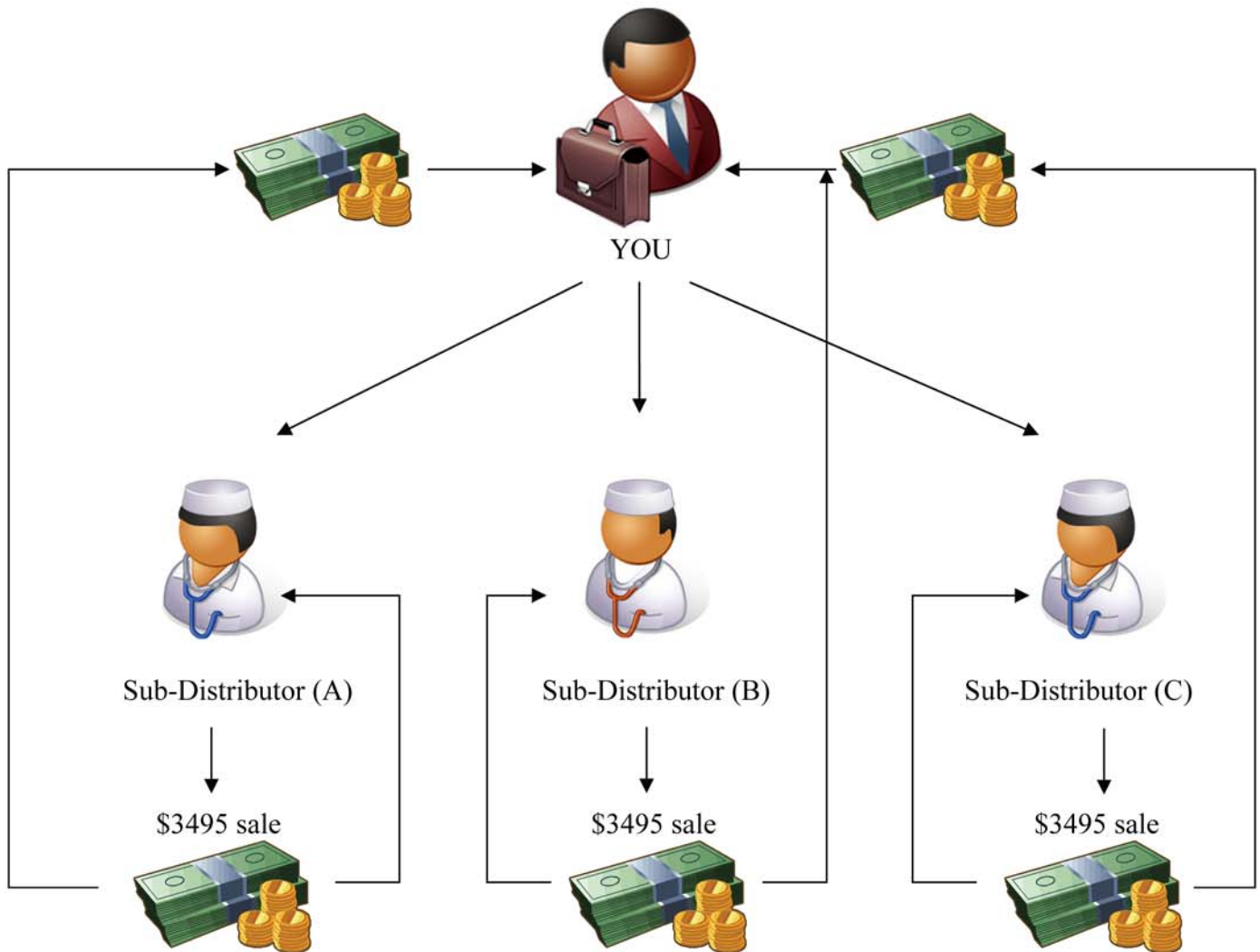


Distributor Compensation Plan



Earn a CEO Salary! We'll show you how.

Here's how it works!

You're a new distributor, you go out and find 10 doctors and show them how they can add tremendous revenue to their practice instantly, simply by purchasing at least one Wellness Pro unit!

The doctors are excited!

Why? The unit pays for itself because they can bill insurance.

The doctors start recommending the unit to some of their patients and let's say they sell 1 unit per month. That's \$10,000 a month commission to you, not counting the units you sell!!!

Let's suppose you decide to be a POWERHOUSE distributor and set a goal to get 100 Sub-distributors around the country that would sell... OH, let's say just 1 unit every 2 or 3 months for example. This can earn YOU a potential staggering check, between \$45,000 and up to \$150,000 per month...

What if they sell 2 units?



The Details!

Let's say YOU are at the \$1495 price structure:

Your Sub-Distributor (A) is at the \$2495 price structure
Your Sub-Distributor (B) is at the \$1995 price structure
Your Sub-Distributor (C) is at the \$1495 price structure

All distributors make the difference between the sale price and where they are in the price structure. Retail Price \$3495.

In the example above Your Sub-Distributor (A) made \$1000 commission, Your Sub-Distributor (B) made \$1500 commission and Your Sub-Distributor (C) made \$2000 commission from their direct sales.

YOU in this example made the difference between your price structure and your sub-distributors price structure.

Here's what it looks like:

YOU made \$1000 on the sale made by Sub-Distributor (A)
YOU made \$500 on the sale made by Sub-Distributor (B)
YOU made \$0 on the sale made by Sub-Distributor (C)

WHAT? Why didn't I make anything on Distributor (C)?

Because Sub-Distributor (C) achieved as many sales as you have and now is at the lowest possible price. Therefore there is no more difference between your price structure and your distributor.

It's OK, by this time you made a lot of money on this Sub-distributor. It's time to let go... Find a NEW ONE!

NOTE: This is a **Sub distributor** sales program.

This is **NOT** an MLM Marketing deal with break away arms and legs.

This is a Clean and Simple Program that requires some effort on your part: **Contact** a few doctors, **Send** out a few brochures, **Make** a few calls. **That's it!**

I Just Started. What's my commission?

If YOU just started, you purchased a unit and you are now at the \$2995 price structure. Lets say you have a Doctor that wants a unit for his clinic. Any health practitioner gets \$500 off of the Retail Price setting their price at \$2995. This puts them at your price structure.

Don't Worry! You are then entitled to sales bonus of \$300.

"On your mark, get set...GO!"

Start EARNING A CEO SALARY TODAY! Make positive changes in your life and in the lives of others!

Follow these easy steps:

1. **Become a Distributor** – To be a distributor you need to own a unit. You have to have one to understand how the unit works so you can recommend it. * Special consideration available.
2. Now as a Distributor, you start sending out information. Start setting up appointments and **find** at least **10 doctors** that have an interest in dramatically increasing their revenue, by having a Wellness Pro unit in their office. * See chart below

Congratulations! You just achieved Distributor pricing and you are at the \$1995.00 price! This means that the next time a doctor places an order you will earn \$1000 commission per order. In addition, every time you sell a unit at retail price you will make \$1,500.

The more you personally sell the lower your price becomes!

When you reach the Factory Distributor structure your price will be \$1495!
Your earnings will JUMBO UP to \$2,000 per **Retail** sale and \$1500 per **Practitioner** sale.

Purchased Units	Description	Price
1 st Unit	WellnessPro (Retail)	\$3,495
2 – 4	WellnessPro Instruments (Representative)	\$2,995
5 – 9	WellnessPro Instruments (Representative)	\$2,495
10 – 24	WellnessPro Instruments (Distributor)	\$1,995
25 – 49	WellnessPro Instruments (National Distributor)	\$1,695
50 – 99	WellnessPro Instruments (Master Distributor)	\$1,595
100 +	WellnessPro Instruments (Factory Distributor)	\$1,495

Here's what your commission will look like based on only 1 sale per doctor per month! :

As you can see, even with a minimal charge of just \$35 per pain relief session, with only 4 treatments a day, a doctor's office will make over \$3000 per month and pay off the investment completely. In addition, doctors can recommend the unit to their patients. By doing so, doctors will also earn additional income up to \$2000 per sale.
